A Future Built on Game-Changing Interventions

6 December 2023 online

Objective of the event:

- Presenting, exploring, and debating actions and interventions with a substantial impact on the entire ecosystem of societal inclusion challenges.
- Discussing and setting the agenda for the 2024 work programme based on the findings of Hop-Skip-Jum (work programme 2023).

Identifying 'game-changing' innovative interventions that could have a snowball effect on the social inclusion of the people concerned is crucial. Changing social protection schemes and systems requires a long-term commitment and structural interventions. Rerouting money flows in the system or rewriting legal frameworks is not only complex but also entails the risk of derailing and stopping halfway. Therefore, it is crucial to identify mechanisms and interventions that have a snowball or amplifying effect and can be funded under the ESF+ – rather than limited interventions that have a minor effect on the system itself in the long run.

The event will explore 'game-changing interventions' addressing community living, combating homelessness, and fighting child poverty. These interventions should cover not only the current crisis but also extend beyond it. ESF+ MAs will contribute by presenting validated solutions implemented in their respective countries and/or regions.

As this online event marks the conclusion of 2023, it is essential to reach a consensus on the objectives and actions included in the 2024 work plan.
